Maura Twomey and Diane Eidam will be available for questions.
7. Approval of Professional Services Agreement with Davey-Bates Consulting to Provide Planning Services to MCOG for Fiscal Years 2024/25 through 2028/29. On April 15, 2024, the Executive Committee recommended approval of the DBC proposal. On May 6, the Board of Directors directed the procurement consultant, Regional Analysis & Planning Services (RAPS) to negotiate a contract. Attached is RAPS' report recommending approval of the final draft contract (attached separately). This agreement has been reviewed by County Counsel's office and approved as to form. Maura Twomey and Diane Eidam will be available for questions.
8. Approval of First Amendment to Fiscal Year 2024/25 Transportation Planning Overall Work Program (OWP) – This routine amendment will reprogram funds unexpended in 2023/24 and carried over. At this writing, staff is finalizing the package.  
– *Staff report and amended financial summaries to follow under separate cover*
9. Adoption of Resolution Approving Mendocino Transit Authority's Grant Application for Federal Transit Administration (FTA) Section 5311 Non-Urbanized Program Annual Regional Apportionment for Transit Operating Assistance – This is a routine matter requiring MCOG's approval. Mendocino Transit Authority is eligible for these funds, and staff finds that MTA meets program requirements. The estimated apportionment available to Mendocino County is \$738,115 for FFY 2024 (as reflected in MCOG's budget). Apportionments are up significantly since passage of the Bipartisan Infrastructure Law.  
– *Staff report, resolution and table are attached.*
10. Appointments to Social Services Transportation Advisory Council (SSTAC)  
The SSTAC made nominations to appoint three members to fill vacancies. – *Staff report and roster attached*

11. Award of Fiscal Auditor Engagement for MCOG and Mendocino Transit Authority Audits, Fiscal Years 2023/24 through 2027/28 – Staff issued a Request for Proposals, following national best practices. There was one response to the RFP, from MCOG’s most recent CPA auditor. Staff recommends award of the fiscal audit engagement contracts for the year ended June 30, 2024 to O’Connor & Company and to authorize MCOG’s Executive Director or designee to execute annual agreements for up to a total of five years, consistent with the fee proposals received. The budget is \$26,000 of local funds. The proposed cost is \$12,360 for MCOG’s audit and \$13,390 for MTA’s, with no increase over the past year and no increase proposed over the five-year period. – *Staff report attached.*

### **The Mendocino Council of Governments (MCOG) meets as the Board of Directors of:**

**1. Call to Order and Roll Call.** The meeting was called to order at 1:34 p.m. with Directors present: John Haschak, Mike Carter, and Josefina Duenas in Ukiah; Bernie Norvell and Dan Gjerde in Fort Bragg; and Dean Meester for Caltrans/PAC in Eureka (not voting). Chair Gjerde presiding. PAC member Tatiana Ahlstrand was excused by prior arrangement. Directors Greta Kanne and Jeff Hansen were absent.

Guests: Stephen Kullman and Patricia Terry of Redwood Coast Energy Authority were present on the teleconference as a resource for Agenda #12.

Staff present in Ukiah: Nephele Barrett, Executive Director; Janet Orth, Deputy Director & CFO; Loretta Ellard, Deputy Planner; Michael Villa, Project Coordinator; and Jody Lowblad, Administrative Assistant.

Staff present by Zoom: Lisa Davey-Bates, Transportation Planner; James Sookne, Program Manager.

**2. Assembly Bill 2449 Notifications and Considerations.** This item is to receive and address requests from Board members to participate in the meeting from a non-posted location, subject to conditions set forth in AB 2449. There were no such requests.

### **3. Convene as SAFE – Service Authority for Freeway Emergencies**

- a. Report of Motorist Aid Call Box Program Status. Executive Director Barrett summarized her written staff report. Currently the SAFE is in process of upgrading call boxes, though spare parts are not easily available, so out-of-service “bagged” boxes may be seen on the highways. CASE Systems, the contractor, was recently acquired by Knightscope, a security and robotics company. A number of boxes remain in need of 4G radio upgrades and/or maintenance, including satellite boxes. Staff will be working with Knightscope to resolve these. There are few if any other firms providing these services, so staff hopes to return to normal operations soon. There were no Board questions or discussion. No action was taken.

- b. Adoption of FY 2024/25 Mendocino SAFE Budget. Project Coordinator Villa reviewed his written staff report, describing the SAFE enabling legislation, purpose and funding source, \$1 per vehicle registration fee collected by California Department of Motor Vehicles (DMV). He noted total revenues and expenditures budgeted, including estimated carryover funds. Revenues have been steady for many years. Expenditures are detailed in the budget. The planning contractor, Davey-Bates Consulting (DBC) anticipates unused funds at the end of the current contract period, September 30, 2024, will be returned to the SAFE fund balance. 31 callbox upgrades are needed, with 20 budgeted in the coming fiscal year, assuming the equipment is available. Board questions and discussion included:

Director Haschak asked about the difference between budget and actual expenses over the past two years, and how much SAFE would actually spend in the next year. Mr. Villa expected some carryover and hoped that upgrade installations could be fully expended. Ms. Barrett explained budgeted items are maximum amounts, including cumulative prior-year balances carried forward resulting from lack of available parts for timely system upgrades, and savings from repurposed spare parts released by other SAFE agencies. It is likely the estimated \$208,000 expense budget will be less, though unknown at this point. Some uncertainties remain due to supply chain and a new service contractor. Director Haschak commented that the work needs to be done, while keeping to a sustainable budget.

The Chair called for public comment, with none heard.

**Upon motion** by Carter, second by Haschak, and carried unanimously on roll call vote (5 Ayes – Haschak, Carter, Norvell, Duenas and Gjerde; 0 Noes; 0 Abstaining; 2 Absent – Kanne and Hansen): IT IS ORDERED that the FY 2024/25 SAFE Program Budget is approved as recommended by staff.

**9. Public Expression.** Steve Henderson, a.k.a. Gizmo, spoke in recognition of public transit and school bus drivers.

**10. Fiscal Year 2024/25 RTPA and COG Budget.** Ms. Orth referred to her written staff report, summarizing final notes and changes since the May draft budget workshop. The budget package was made available as a separate electronic document along with the agenda packet, with print copies available by request. Total revenues come to \$16,442,032 and total proposed allocations \$9,849,165. A substantial amount remains for later allocation, primarily due to delay of the State budget in releasing the new Senate Bill 125 formula transit capital funds (\$5.3 million in this budget). She and Ms. Barrett explained how this affected the Administration budget’s funding sources, with some flexibility as shown in the allocating resolution’s Exhibit A.

Public transit allocations are as recommended during budget development, though a budget amendment is now anticipated to reallocate an estimated \$1,750,000 of Local Transportation Funds as a result of federal Covid-relief funds received by MTA, identified in FY 2022/23 fiscal audits. Ms. Barrett added that once this is resolved in the coming year, MTA plans to request that MCOG amend its SB 125 allocation plan to claim remaining funds and address an operations shortfall.

The final budget proposal was recommended by the Executive Committee, Technical Advisory Committee, Transit Productivity Committee, Social Services Transportation Advisory Council and staff. In Board discussion, Director Haschak asked about the significant funding cut to Senior Centers transportation programs. Staff reported hosting a workshop on May 30, so the directors have been informed and relief options will be explored. MCOG cannot directly provide funding, only allocate certain funds through MTA, who contracts with the centers for services.

The Chair invited public comments; none were made.

**11. Acceptance of Transit Productivity Committee Report of May 2, 2024 – Annual Transit Performance Review.** Ms. Orth reported the recommendation, summarizing her written report. No changes were recommended to MCOG’s adopted Transit Performance Standards. The most recent adjustment was to Passengers per Hour, and the TPC agreed to allow more time to rebuild ridership post-pandemic before making any further changes to those targets. She briefly covered the other adopted standards, which are working well with annual administrative adjustments per policy.

In the annual performance review, the data showed level results or better, as calculated in tables provided in the agenda packet along with staff report summarizing results. Notably, all service types showed a drop in costs. The TPC recommended that MCOG be aware of opportunities to support and market specialized transportation services provided by the Senior Centers to help increase ridership.

The Chair invited public comments, hearing none.

**Upon motion** by Haschak, second by Carter, and carried unanimously on roll call vote (5 Ayes – Haschak, Carter, Norvell, Duenas and Gjerde; 0 Noes; 0 Abstaining; 3 Absent): IT IS ORDERED that: 1) MCOG’s 2024 Transit Performance Standards are approved as presented;

- 2) the committee’s report of Annual Transit Performance Review through December 31, 2023 is accepted, noting improvement in fixed route performance, maintenance of effort by DAR and by Senior Centers specialized services as a whole, and cost reduction for all service types over the past year;

Discussion/Consideration of RuralREN (Regional Energy Network) Developments.** Ms. Barrett summarized her report, including the Petition for Modification by Redwood Coast Energy Authority (RCEA) to the California Public Utilities Commission (CPUC), other petitions and responses, and a new Administrative Law Judge’s Ruling Seeking Comment on Potential Path Forward for Rural Regional Energy Network. This last proposal would divide the RuralREN into two separate entities, RREN North and RREN Central. MCOG had taken a neutral position during this period. To make official comments, due June 14, it is necessary to file a motion for party status. A new RREN North program could start in January at earliest.

Mr. Kullman and Ms. Terry of RCEA were on hand for questions. Board discussion included:

- Would there be approximately same amount of money for Mendocino County as before? The proposal was a little higher, since the original business plan was not quite adequate to meet needs with MCOG as a subcontractor. With MCOG as a full members under the ALJ proposal, the underfunding would be addressed; this would remain to be resolved with other regional partners to the REN. (Gjerde, Barrett)
- Would MCOG be a full partner? RCEA would agree to that if MCOG so desires. Staff’s report was accurate. Concerning a breakdown of funds among partners, in refiguring the budget, RCEA did increase the allocation for MCOG from the original business plan that was filed. (Haschak, Kullman)
- Good news that MCOG would become a full partner in a new configuration. (Gjerde)
- This will serve the northern part of the state better and be a more manageable program, even though it has been a bit painful to reach this point. A new RuralREN North entity will be more truly rural than before. (Kullman, Barrett)

There was no public comment on this item.

**Upon motion** by Haschak, second by Carter, and carried unanimously on roll call vote (5 Ayes – Haschak, Carter, Norvell, Duenas and Gjerde; 0 Noes; 0 Abstaining; 3 Absent): IT IS ORDERED that staff is authorized to file a Motion for Party Status and submit comments to the California Public Utilities Commission on the Administrative Law Judge’s ruling of May 21, 2024 by the June 14, 2024 deadline.

**13. Consideration of Letter to Support Implementation of Roadside Wildfire Prevention Measures for Trailers in California.** Ms. Orth introduced Steve Henderson, a.k.a. Gizmo, who made the proposal and had authored a sample letter, provided in the agenda packet. He demonstrated the proper way to attach a trailer with ball-type drawbar style connection. As a volunteer firefighter, he has seen failures from improper installation, causing chain dragging and ignition from sparks. Educational information is needed at point of sale, using a QR code to access best practices. This and other measures, such as a compliance sticker to enforce existing California regulatory code, would address much of the “miscellaneous” category of causes of roadside wildfires in the state.

Chair Gjerde thanked Mr. Henderson for bringing this to everyone’s attention and supported sending a letter to DMV and others as proposed, with minor changes such as adding California Highway Patrol (CHP) to the distribution. Additional recipients were mentioned in discussion.

Director Haschak also thanked Henderson for his work on this issue to date and agreed with the need for action, advising that staff assist with drafting a support letter. Discussion followed on Henderson’s additional recommendation to repurpose fire hoses for covering trailer chains.

**A motion was made** by Director Norvell, seconded by Director Haschak to send a letter of support as proposed. **Discussion on the motion:** Director Carter advised requesting that DMV hand out information rather than CHP, so that everyone receives information while purchasing a trailer or renewing a license, rather than at random stops, noting that CHP motorcycle officers have limited space to carry materials. He objected to the term “mandatory” for CHP traffic stops, otherwise was in support. Ms. Barrett stated that normally this level of detail would not be included in a support letter. Director Gjerde asked to clarify the motion authorizes staff to prepare a letter and does not need to come back to Board; the motion maker concurred. Director Haschak was confident that staff would draft an acceptable letter. There was no public comment.

**The motion carried** unanimously on roll call vote (*5 Ayes – Haschak, Carter, Norvell, Duenas and Gjerde; 0 Noes; 0 Abstaining; 3 Absent*): IT IS ORDERED that staff is directed to send a letter to the following agencies in support of wildfire safety measures for trailers sold in California:

- Department of Motor Vehicles (DMV) Safety Division
- California Department of Highway Patrol (CHP)
- California Insurance Commissioner
- Caltrans Safety Programs
- Senator Mike McGuire
- Assemblymember Jim Wood
- Various Mendocino County fire authorities

**14. Recess as Policy Advisory Committee – Reconvene as RTPA – Ratify Action of Policy Advisory Committee.** **Upon motion** by Haschak, second by Carter, and carried unanimously on roll call vote (*5 Ayes – Haschak, Carter, Norvell, Duenas and Gjerde; 0 Noes; 0 Abstaining; 2 Absent*): IT IS ORDERED that the actions taken by the Policy Advisory Committee are ratified by the MCOG Board of Directors.

### **15. Reports - Information**

- a. Caltrans District 1 – Projects Update and Information. Planner Dean Meester noted the Milestone report provided in the agenda packet.
- b. Mendocino Transit Authority. Executive Director Jacob King stated no report this month.
- c. Great Redwood Trail Agency. Director Haschak reported a meeting was held May 16 and that the Draft Master Plan was still open for public comment.

- d. MCOG Staff - Summary of Meetings. Ms. Barrett referred to the written report.
- e. MCOG Administration Staff
  - i. *Status of Staffing Contracts Negotiated by the Procurement Consultant, Regional Analysis & Planning Services (RAPS) – to August 12 meeting*. Ms. Barrett reported briefly that the consultant had stated last meeting that contracts would be ready for approval today, however that timeline did not allow for legal counsel review. The contracts are expected to be ready for the next meeting agenda.
  - ii. *Miscellaneous*. None.
  - iii. *Next Meeting Date* – Monday, August 12, 2024 (Note second Monday of the month).
- f. MCOG Planning Staff
  - i. *Work Element 9 - Noyo Harbor Multimodal Circulation Plan*. Deputy Planner Ellard gave an update on this project. She had expected a consultant to be under contract by now; this was delayed for an extra step to interview the top two proposers. Staff is now in final negotiations with the top-ranked proposer and expects to execute a contract in a week or so, followed by a kickoff meeting. A key component will be public outreach, which will be coordinated with the Noyo Harbor Blue Economy effort now underway. The project is anticipated to take about a year and a half to conduct.
  - ii. *Work Element 10 - Update/Expand Local Road Safety/Action Plans*. Ms. Ellard reported this project is wrapping up. Since last reported, two in-person stakeholder workshops and one virtual were held. Attendance has been low although advertised. One board member attended each, along with local agency staff and a few public members. The project team and member agencies will meet next and plans are to be completed by end of June, with presentations to each city council and the Board of Supervisors. This will put the local agencies in a good position to apply for the next rounds of federal highway safety and safe streets grants.
  - iii. *Miscellaneous*. None.
- g. MCOG Directors. None.
- h. California Association of Councils of Governments (CALCOG) Delegates. Director Haschak reported that CALCOG met May 22 in Sacramento for Legislative Day lobbying, which included a hybrid teleconference board meeting he was able to attend. They discussed SB 125 and other State budget updates.

**16. Adjournment.** The meeting was adjourned at 3:05 p.m.



#### **BACKGROUND:**

Mendocino Transit Authority (MTA) has applied to Caltrans for funds available under the Federal Transit Administration (FTA) Section 5311 Non-Urbanized Program for Federal Fiscal Year 2024. The estimated amount of Mendocino County's regional apportionment is \$738,115. Applications were due by May 30, 2024.

“On April 4, 2024, FTA announced \$20.5 billion in federal funding available to support public transportation throughout the country, the latest tranche of support made possible thanks to the [Bipartisan Infrastructure Law](#). The funding to states, urbanized areas and tribal governments is based on statutory formulas set in law and represent a full year of federal support for transit.”

MTA is a sub-recipient under MCOG as the regional agency. The funds can be used for operating, capital or planning. The proposed project consists of transit operations that the program is meant to assist in rural areas. Staff is not aware of any other claims. Eligible applicants must provide transit to the general public. Note that MTA is the designated Consolidated Transportation Services Agency for the region.

Executive Director Barrett's signature on the Certifications and Assurances represents MCOG's understanding that MTA complies with certain standard requirements related to local funding match availability, coordination with public transportation stakeholders, and STIP requirements. (Certification statements are available by request.)

This has been considered a routine item with no reason to withhold support. Also note that when allocating Local Transportation Funds, the Transportation Development Act (TDA) requires a finding by MCOG of whether MTA is making full use of available federal funds.

---

#### **ACTION REQUIRED:**

Adopt the resolution to program these funds for MTA's Operating Assistance.

---

#### **ALTERNATIVES:**

If MCOG does not approve this action, MTA will not receive the federal operating assistance for which they are eligible. If another eligible recipient or subrecipient were to make a claim under this year's program, it would need to have been submitted by the May 30 due date in Caltrans' call for projects.

---

#### **RECOMMENDATION:**

Adopt the attached resolution approving the programming of MCOG's FFY 2024 regional apportionment of FTA Section 5311 Non-Urbanized Program funds for transit operating assistance and authorizing the Executive Director's signature on certification documents for MTA's application.

**TITLE:** Award of Fiscal Auditor Engagement for MCOG and Mendocino Transit Authority Audits, Fiscal Years 2023/24 through 2027/28

### **BACKGROUND:**

The Transportation Development Act (TDA) requires that both MCOG and Mendocino Transit Authority (MTA) are audited independently each fiscal year. To ensure compliance, MCOG has traditionally engaged auditors for both audits, paid from our administration budget.

Also, MCOG's Joint Powers Agreement states: *"There shall be strict accountability by all parties and by MCOG of all funds. MCOG shall contract with a certified public accountant to make an annual audit."*

MCOG engaged R. J. Ricciardi, CPAs for the previous five-year period (and earlier). During that time Mr. Ricciardi retired and his partner Michael O'Connor started a new firm, O'Connor & Company, who completed the last two annual fiscal audits for MCOG and MTA.

Procurement. In this case staff selected micro-purchase along with major elements of the Informal Request for Proposals (RFP) method, known as "small procurement," for each RFP, consistent with MCOG's adopted policies and procedures.

I updated our list of qualified CPAs and issued two separate RFPs on July 18, 2024, distributed to 12 CPA firms by email and posted to MCOG's website. Only one proposal for each RFP was received by the due date of August 2, from our current auditor O'Connor & Company. For reference, the RFP may be found at: <http://www.mendocinocog.org/news-notices>

A review panel of MCOG and MTA staff members (myself and Mark Harvey) reviewed and scored the proposals for responsiveness to the RFP. The proposal was found to be more than responsive and the firm highly qualified, with a combined score of 395 of a maximum 400 points.

Since major criteria include familiarity with TDA and transit, the field of qualified auditors is quite limited. We have found it difficult in the past to find available CPAs that serve rural agencies. Other rural transportation agencies in California also have had trouble finding auditors at an affordable cost. Therefore, we believe that in this case a sole source is justified.

Cost. A five-year estimate is requested, with engagements to be signed annually. The proposed cost is \$12,360 annually for MCOG's audits and \$13,390 for MTA's. These equate to actual costs for the most recent audits, with no increases quoted over the five-year period. These estimates assume that any additional services outside the direct scope of audit work will be billed at hourly rates. The estimates are within MCOG's 2024/25 budget of \$26,000 for both audits, and are more than reasonable given inflation.

Auditor Rotation. Based on my prior research and guidance from both the Government Accounting Office (GAO) and the Government Finance Officials Association (GFOA), we are aware that auditor rotation is not necessarily advisable for public sector entities. For instance, a new perspective or other benefits can be gained, while losing some degree of efficiency, continuity, and institutional knowledge. If rotation is pursued, a periodic open solicitation is advised when an auditor engagement expires, to include the current auditor, for a five-year engagement. Staff is not seeking rotation now, merely following best practices for open and public procurement of financial services.

If the Council wishes to pull this item from Consent Calendar, staff will be prepared to answer questions.

---

**ACTION REQUIRED:**

Award a contract to a qualified independent Certified Public Accountant or CPA firm to conduct fiscal audits of both MCOG and MTA for a minimum of one fiscal year, ending June 30, 2024.

---

**ALTERNATIVES:**

- 1) Reissue the Request for Proposals. – *not recommended, in the interests of time and audit due dates*
  - 2) Conduct a “competitive” formal Request for Proposals for a five-year engagement of \$130-140,000. – *not recommended, as it would not be timely nor a productive use of staff time and resources*
- 

**RECOMMENDATION:**

Award the fiscal audit engagement contracts for the year ended June 30, 2024 to O’Connor & Company and authorize MCOG’s Executive Director or designee to execute annual agreements for up to a total of five years, consistent with the fee proposals received.

**BACKGROUND:**

The Gualala Downtown Streetscape project is a Caltrans implemented project that will provide bicycle and pedestrian facilities on SR 1 through downtown Gualala. The project is funded with a combination of MCOG's State Transportation Improvement Program funds and a competitive Active Transportation Program (ATP) grant. As part of the 2024 RTIP, MCOG approved an additional \$1.2 million for construction of the project to cover cost increases since approval of the ATP grant.

The project has been in development for many years, with multiple rounds of public meetings and input. Since the environmental document was finalized in November, Caltrans has been working to finalize details of the project as they work through the design and right-of-way components of the project. Some variations of project design, such as curvilinear sidewalks and two-way left turn lane through the entire length of the project, were considered and subsequently determined to be infeasible given the site and project constraints. Other aspects of the project, such as ongoing landscape maintenance, have yet to be finalized.

At this meeting, Project Manager Katie Everett will provide an update on the project and answer questions. This will be an opportunity for MCOG Board members, as one of the funding agencies, to discuss and provide comment on the project as it proceeds through final design and right of way acquisition.

**BACKGROUND:** In 2019, AB 101 established the Local Government Planning Support Grants Program (LGPSGP), intended to fund planning related to housing production and implementation of the Regional Housing Needs Allocation (RHNA). The Regional Early Action Planning (REAP) Program, created under the LGPSGP, provided one-time, formula-based funding to multi-county agencies or COGs responsible for RHNA. Under this program, MCOG was eligible to receive a total of \$383,245 to be used for activities that “increase housing planning and accelerate housing production.” As part of the original REAP allocation, MCOG, using the Board approved funding distribution formula, suballocated \$344,920.50 to the five local jurisdictions. Since the original sub-allocation in 2021, there have been two revisions that have been submitted to the California Department of Housing and Community Development (HCD) that have modified some of the agencies’ scopes of work, the most recent being:

City of Ukiah	\$69,536.37	For new permitting software
City of Point Arena	\$16,380.67	To update the ADU ordinance
City of Willits	\$35,364.85	For an administrative draft of the environmental document for a General Plan amendment
County of Mendocino	\$177,228.42	For new permitting & GIS software
City of Fort Bragg	\$46,410.19	For a Community Land Trust & permitting software

With the REAP Program wrapping up and grant funds expiring on November 1, 2024, staff has identified approximately \$86,100 that can be reallocated to the local agencies so MCOG can fully expend the grant funds. Staff reached out and the Cities of Fort Bragg, Ukiah, and Willits have expressed a need for additional funding for their existing projects. The City of Ukiah requested approximately \$26,000, Fort Bragg up to approximately \$50,000, and Willits up to the entire amount if available. Staff feels that the most equitable way to distribute the funds would be based on a variation of the percentages of their original allocations. This would make the third, and final, revision look like the following:

City of Ukiah	\$95,448.53	For new permitting software
City of Point Arena	\$16,380.67	To update the ADU ordinance
City of Willits	\$61,403.80	For an administrative draft of the environmental document for a General Plan amendment
County of Mendocino	\$91,105.73	For new permitting & GIS software
City of Fort Bragg	\$80,581.77	For a Community Land Trust & permitting software

Like the two previous revisions, this one will need to be approved by HCD before MCOG can seek reimbursement for the remaining funds. In anticipation of Board approval and to expedite the process, staff have already submitted the revision to HCD for their approval. If approved by the MCOG Board and HCD, the changes will be reflected in the next MCOG budget amendment. Staff will be available at the meeting to answer any questions.

**ACTION REQUIRED:** Approve the re-allocation of REAP funds as proposed in the third revision.

**BACKGROUND:** In February 2022, the MCOG Board approved a Memorandum of Understanding with Redwood Coast Energy Authority (RCEA) to participate in the newly formed Rural Regional Energy Network (RuralREN). At that time, development of the RuralREN had been underway for quite some time, and the business plan was nearly complete. Due to the timing of the addition of Mendocino and Lake Counties to the RuralREN, MCOG's initial participation was to be via subcontract with RCEA, with the intent to work toward becoming full a RuralREN partner. In addition to RCEA, the RuralREN partner agencies include Sierra Business Council, San Luis Obispo County, Association of Monterey Bay Area Governments, Kern County, Ventura Regional Energy Alliance, High Sierra Energy Foundation and San Joaquin Valley Clean Energy Organization.

The business plan for the RuralREN was approved by the California Public Utilities Commission in June of 2023. However, differences in implementation strategies and administrative practices among the partners soon became apparent following that decision. After several months of petitions followed by comment and reply periods and CPUC consideration, a CPUC Administrative Law Judge released a ruling seeking comment on a potential split of the RuralREN. This solution would split the original RuralREN into two (Northern and Central). RuralREN North would include Humboldt, Lake, Mendocino, and the Northern Sierra region represented by Sierra Business Council (Alpine, Amador, Butte, Calaveras, El Dorado, Lassen, Mariposa, Nevada, Placer, Plumas, Sierra, Sutter, Tuolumne, and Yuba) with RCEA as the lead administrator. RREN-Central, with SLO as the lead administrator, would include Monterey, San Benito, Santa Cruz, San Luis Obispo, Fresno, Kern, Kings, Madera, Merced, San Joaquin, Stanislaus, Tulare, Inyo, and Mono.

At the June meeting, the MCOG Board authorized staff to file a Motion for Party Status in order to express support for the solution. Since that time, party status has been approved, we have submitted comments in support, and other REN partners have indicated support. Although there is some opposition from the Public Advocates Office, the comments overall have been supportive.

MCOG has been meeting with the proposed RuralREN North partners to discuss a new MOU and bylaws. A final draft will be distributed for legal counsel review in the next few weeks. Partners have also begun discussing the implementation priorities and strategies. Once a final decision is made by the CPUC, the new RuralREN North will have to submit an advice letter with a plan for implementation.

The original RuralREN business plan and CPUC decision included delivery of seven programs, briefly summarized below. Although the intent is to implement all programs in Mendocino County during the approximately four-year initial period of Rural REN-North operation, it's unrealistic to attempt to launch all of them immediately. We recommend beginning with a focus on the Residential Equity Program, Residential Resource Acquisition Programs, and Finance as these programs really tie in with one another. The next priority would be the Non-Residential Resource Acquisition and Public Equity Programs. It's expected that Work Force Education & Training and

Codes & Standards Programs will take a little more up front work before launching, so they will naturally need to come later in implementation.

**The Residential Equity Program:** This program will increase energy efficiency awareness in our communities. The program will also offer a basic energy efficiency “toolkits” containing simple energy efficiency and conservation education material as well as easy to install energy efficiency equipment such as LED lightbulbs and power strips. Finally, the program will offer energy efficiency audits which will also provide actionable energy efficiency and electrification project recommendations as well as guide customers towards qualified external incentives programs and financing solutions.

**The Residential Resource Acquisition Program:** This program will offer incentives for common home energy upgrades and GHG reducing technologies such as heat pumps. Financing will also be made available to enable customers to implement energy projects with no capital outlay. The RuralREN finance offering is described in the finance equity program section below.

**Non-Residential Resource Acquisition Program:** This program will offer financial incentives to small and medium sized businesses for energy efficiency upgrades and improvements. Region specific outreach and energy audits will provide specific, actionable recommendations for improving the place of business to reduce energy consumption and will guide the customer toward available incentives and financing options. Financing will also be made available to enable customers to implement energy projects with no capital outlay. Financing offerings are described in the Finance equity program section below.

**Public Equity Program:** This program will offer services to public agencies in the region to identify, develop, track, and implement energy savings projects in their buildings and facilities. This program will also connect agencies to external incentives programs and financing offerings and increase awareness and expertise of public agency staff.

**Workforce Education and Training Equity Program:** This program will provide energy efficiency training and upskilling to community members through hands-on training, career support and placement services. The details of this program will be developed with RuralREN-North partners, but will include a focus on underserved communities.

**Codes and Standards Program:** This program will support code enforcement agencies as well as the building design and construction community to better understand and implement California’s ambitious Building Energy Efficiency Standards (Title 24), helping make buildings more efficient, paving the way for zero net energy building stock, and reducing energy use and greenhouse gas emissions in our region.

**Finance Equity Program:** The Finance Program will address first cost and access to capital barriers that exist in Public, Small Business and Residential sectors in rural California by providing guidance and support to rural customers during their participation in energy efficiency related funding and financing offerings. This program will also operate a short-term bridge loan offering for small businesses and local government agencies. The “bridge” funding will allow cash strapped, small businesses and rural local government agencies to implement energy efficiency projects more quickly. Finally, this program will also run a residential loan offering for energy efficiency upgrades.

At this meeting we would like MCOG Board input on priorities for implementation.

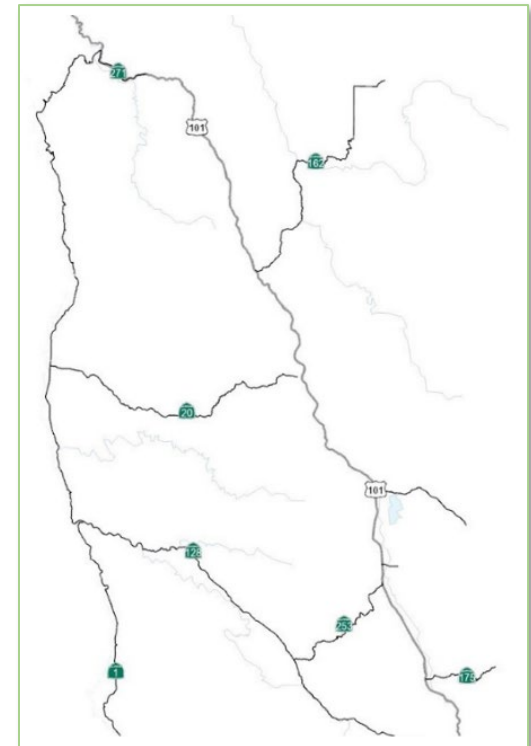

### Project Initiation Document

A PID is a document that is meant to take a transportation project concept or idea and scope it. It identifies the purpose and need of the project and feasibility of delivering it in terms of an estimated cost, environmental studies needed, and potential project impacts and mitigation, and schedule.

A PID must be developed and approved by Caltrans for major capital projects on the state highway system. This is an essential first step in the project development process. Once an idea becomes a PID, it is then eligible to seek funding and programming as a project, apply for discretionary grant programs, and proceed to the next phase of project development, the Project Approval and Environmental Document (PA&ED) phase.

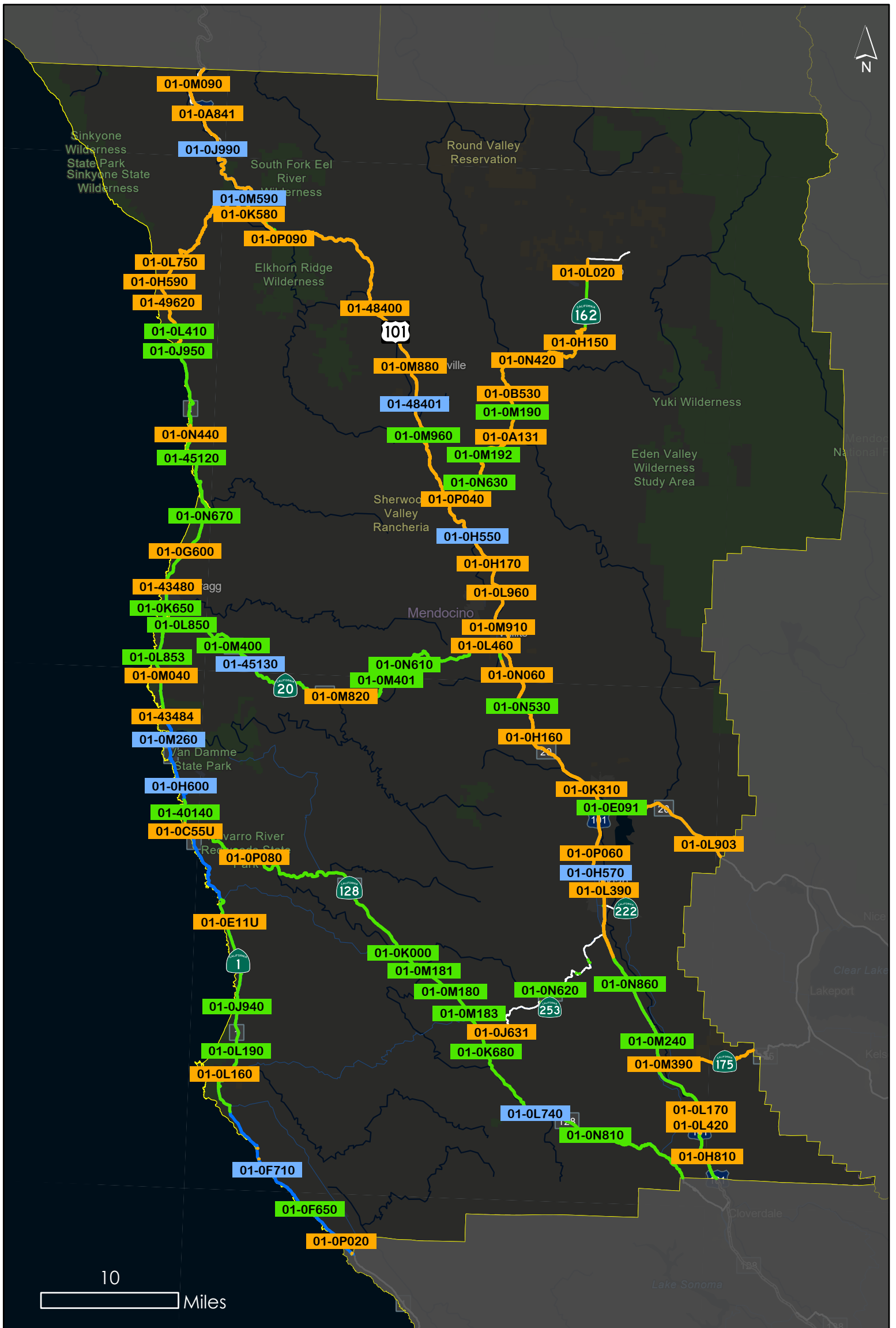
