### BACKGROUND:

According to MCOG's bylaws, a Chair and a Vice Chair are elected annually by the Board of Directors, typically on the first Monday in February, as the first meeting of the calendar year. The appropriate sections of the bylaws are attached for your reference.

Officers serving in 2024 have been Dan Gjerde, Chair and John Haschak, Vice Chair.

*(This item is placed early on the agenda, since officers are elected to serve the Council regardless of which body is convened -- RTPA, SAFE, or simply as the COG for other business such as housing or economic development. Committee appointments are placed later on the agenda, as their business is mostly related to the Regional Transportation Planning Agency and should be made after convening the Policy Advisory Committee.)*

---

### ACTION REQUIRED:

Follow past years' method or vote to use another method.

Procedure followed since 2012, consistent with Robert's Rules of Order<sup>1</sup>:

1. Hear any and all nominations for the office of Chair. A second is not required to nominate.
  2. Discuss and answer questions. Nominees may state their qualifications for the office.
  3. Close nominations.
  4. Move, second and vote on each nominee until a motion carries.
  5. Repeat for the office of Vice Chair.

### ALTERNATIVES:

According to Robert's Rules, *"If no method of nominating has been specified in the bylaws and if the assembly has adopted no rule on the subject, any member can make a motion prescribing the method."* The bylaws do not specify, and to our knowledge MCOG has never adopted, a formal rule of procedure.

The Council may adopt a rule, by motion and vote. Staff would advise that such a rule be written and ratified at a future meeting.

No alternative to the annual election is identified. According to the bylaws, *"The term of the Chair shall be for one (1) year, commencing on the first Monday in February when elected and ending on the following first Monday in February or at the next officers election."*

### RECOMMENDATION:

Allow staff to receive nominations and conduct votes, first for Chair and then for Vice Chair. After that, the new or re-elected Chair or Vice Chair presides over the meeting.

<sup>1</sup> "A nomination is, in effect, a proposal to fill the blank in an assumed motion 'that \_\_\_\_\_ be elected' to the specified position. In choosing someone to fill an office or other elected position in a society or assembly, a more effective freedom of choice is maintained through the practice of nominating persons for the office, rather than moving that a given person be elected as in the older British procedure." - Robert's Rules of Order, 2000 edition

## Excerpt of MCOG Bylaws Amended June 6, 2022

### ARTICLE III - OFFICERS/STAFF/COMMITTEES

Section 1.1 Chair: The Chair of the Council shall be selected by a majority of its voting members. The term of the Chair shall be for one (1) year, commencing on the first Monday in February when elected and ending on the following first Monday in February or at the next officers election.

Section 1.2 Powers of Chair: The Chair, when present, shall preside at all meetings of the Council. The Chair shall preserve order and decorum and shall decide all questions of order subject to the action of a majority of the Council. The Chair shall be permitted to participate in debate without surrender of the chair. The Chair shall be permitted to vote, move, and second a motion. If the Chair is absent, then the Vice Chair shall preside. If both the Chair and Vice Chair are absent, a chair *pro tem* may be appointed for the purposes of the meeting.

Section 2. Vice Chair: The Vice Chair of the Council shall be selected by a majority of its voting members. The term of the Vice Chair shall be for one (1) year, commencing on the first Monday in February when elected and ending on the following first Monday in February or at the next officers election. The Vice Chair shall have all of the powers and act in the place of the Chair in his/her absence.

**1. Call to Order and Roll Call.** The meeting was called to order at 1:31 p.m. with Directors present: John Haschak, Mike Carter, Josefina Duenas and Greta Kanne in Ukiah; Bernie Norvell in Fort Bragg; Jeff Hansen in Point Arena; PAC member Tatiana Ahlstrand was excused by prior arrangement. Presiding as Acting Chair, Vice Chair Haschak noted that Chair Gjerde's final meeting had been in November, as he had accepted employment with Caltrans and resigned from the County of Mendocino Board of Supervisors.

Staff present in Ukiah: Nephele Barrett, Executive Director; Janet Orth, Deputy Director & CFO; and Jody Lowblad, Administrative Assistant.

Staff present by Zoom: Lisa Davey-Bates, Transportation Planner; James Sookne, Program Manager; Alexis Pedrotti, Project Manager; and Jaclyn Christian, Regional Project Analyst.

**2. Assembly Bill 2449 Notifications and Considerations.** This item is to receive and address requests from Board members to participate in the meeting from a non-posted location, subject to conditions set forth in AB 2449. There were no such requests.

**3. Approval of Executive Committee Recommendation of October 15, 2024: Authorizing Executive Director to Sign the RuralREN North Memorandum of Agreement (MOA) & Bylaws of the Four Governing Partners – to establish energy efficiency programs.** Ms. Orth summarized her written report on status and background of staff's efforts to date in establishing the RuralREN North. The committee met October 15 and recommended approval of the draft MOA in concept and authorize the Executive Director to sign the MOA after County Counsel has reviewed and the MOA has been finalized by the RREN North partners.

**Upon motion** by Duenas, second by Kanne, and carried unanimously on roll call vote (6 Ayes – Carter, Kanne, Hansen, Norvell, Duenas and Haschak; 0 Noes; 0 Abstaining; 0 Absent): IT IS ORDERED that the Executive Director is authorized to sign the RuralREN North (Regional Energy Network) Memorandum of Agreement and Bylaws on behalf of MCOG, as recommended by the Executive Committee.

**8. Public Expression.** Steve Henderson, a.k.a. Gizmo, thanked departing board members for their time as volunteers. Also he recognized a traffic death over the holiday weekend near Fort Bragg. He continues to attend MCOG meetings for both personal and community reasons. Concerns include the need for a new public transit mall, traffic speeding in rural areas, safety policies for non-motorized transportation, redesign of parking lots for better use of space, preparedness for emergency evacuations, opportunities for EV charging stations, and safety in the environment.

**9. First Amendment to Fiscal Year 2024/25 RTPA & COG Budget – Executive Committee Recommendations of October 15, 2024 and Previously Approved Allocations.** CFO Orth reviewed her written staff report, noting changes since the Budget was adopted in June. The proposed amendment gathered together several board actions and recommended actions to formalize allocations by resolution detailing each action and making any required findings. When adopted, the budget document would be updated and posted online, with print copies available by request. Total revenues came to \$19,168,765 and total proposed allocations \$12,374,872. A substantial amount remained for later allocation, primarily from the new SB 125 formula transit capital program, approved by the Legislature and now needing work to develop a local claiming procedure, as well as an allocation plan amendment.

Item #9a updated the resolution for Administration and Planning allocations, reflecting approval of staffing contracts and amendments to the Overall Work Program (OWP), replacing estimates with actuals where applicable, and adding the first portion of available RuralREN North energy funds. Item #9b dealt with recovery and reallocation of funds to Mendocino Transit Authority, after research and numerous meetings. Items #9c-e were considered routine.

In Board discussion, Director Kanne praised the presentation of this material, appreciating the transparency and care taken for the benefit of Board members, the public, and future reference.

The Chair invited public comment. Mr. Henderson asked about funding for a transit project that staff confirmed was approved under Agenda item #7 on the Consent Calendar.

**Upon motion** by Kanne, second by Duenas, and carried unanimously on roll call vote (*6 Ayes – Carter, Kanne, Hansen, Norvell, Duenas and Haschak; 0 Noes; 0 Abstaining; 1 Absent – Ahlstrand/PAC*): IT IS ORDERED that the First Amendment to the FY 2024/25 RTPA & COG Budget is approved with adoption of the following resolutions, and staff is authorized to incorporate the resolutions with amended tables into the full budget document package.

**10. Discussion/Direction and Possible Adoption of 2025 MCOG Board Calendar.** Ms. Barrett reported it was customary to preview the draft calendar, then take action at the first meeting of the year when members have been seated, or it could be adopted now if preferred. One adjustment from the typical schedule was recommended: to move the August meeting to third Monday of the month to better accommodate the schedule for the transportation planning work program. Otherwise, the proposed calendar was straightforward. Acting Chair Haschak suggested waiting until February and directed that MCOG meet February 3, 2025. Public comment was invited and none heard. With no further discussion, no action was taken.

**11. Recognition of Departing Board Members.** Ms. Barrett recalled that last month the outgoing chair Dan Gjerde was recognized, and then read two certificates prepared by staff recognizing the services of Directors Bernie Norvell and Josefina Duenas, whose terms were expiring. Brief remarks were made followed by general applause and photos after the meeting.

**12. Recess as Policy Advisory Committee – Reconvene as RTPA – Ratify Action of Policy Advisory Committee.** The Chair called for any comments, and with none heard, called the question. Upon motion by Carter, second by Kanne, and carried unanimously on roll call vote (6 Ayes –

*Carter, Kanne, Hansen, Norvell, Duenas and Haschak; 0 Noes; 0 Abstaining; 0 Absent*): IT IS ORDERED that the actions taken by the Policy Advisory Committee are ratified by the MCOG Board of Directors.

### 13. Reports - Information

- a. Caltrans District 1 – Projects Update and Information. There was no one present to report. In public comment, Mr. Henderson, a.k.a. Gizmo, mentioned status of Redwood Valley interchange improvements on US-101 and commented on conditions at the site. He expressed appreciation for staff who attended MCOG’s November board meeting in Covelo to report on projects in the region.
- b. Mendocino Transit Authority. There was no one present to report.
- c. Great Redwood Trail Agency. Director Haschak reported a Board meeting the following Thursday at 10:30 a.m. with access from both Ukiah and Humboldt County or by Zoom.
- d. MCOG Staff - Summary of Meetings. Ms. Barrett referred to the written report.
- e. MCOG Administration Staff
  - i. *Miscellaneous*. None.
  - ii. *Next Meeting Date* – Monday, February 3, 2025.
- f. MCOG Planning Staff
  - i. *Work Element 3 – 2026 Regional Transportation Plan & Active Transportation Plan*. Program Manager Sookne provided a brief update. The team is finishing up the first round of public outreach, at the upcoming Westport Municipal Advisory Council (MAC) meeting. Currently the RTP Goals & Policies are under review for any needed updates, and the member local agencies are requested to submit short and long-term project lists. Staff will be working with the Great Redwood Trail Agency to help update obsolete North Coast Railroad Authority data and add to the Active Transportation element of the RTP.
  - ii. *Work Element 5 – Mendocino County Sea Level Rise Roadway Impact Study*. Project Manager Pedrotti reported this grant-funded project is now underway. Staff will be working closely with the County Department of Transportation and other stakeholders. A kickoff meeting with Caltrans is coming up, and steps will be taken to hire a consultant. With interest to date from the public, she looked forward to having one on board and being able to start work in March.
  - iii. *Work Element 9 – Noyo Harbor Multimodal Circulation Plan*. Ms. Barrett reported there were some successful outreach events in September and October. The next public engagement event will be in April with a two-day charrette. A survey is open on the project website, with a link at [www.mendocinocog.org](http://www.mendocinocog.org), where comments can also be made on the RTP/ATP update.
  - iv. *Miscellaneous*. None.
- g. MCOG Directors. Director Kanne reported that a new City of Willits mayor would make appointments for special assignments, and she hoped to be reappointed to MCOG; otherwise, she had enjoyed working with this group. Director Duenas also gave thanks and appreciated working with her colleagues on this board. Acting Chair Haschak said their contributions would be missed, and also wished immediate past Chair Gjerde well in his new job. He then thanked all involved for a very successful Covelo field trip, reporting local excitement about transportation projects there, and the effort was appreciated.

- h. California Association of Councils of Governments (CALCOG) Delegates. Director Haschak reported on the in-person meeting of November 15 in Sacramento at the Caltrans board room, which he attended. Issues highlighted were declining gas tax revenues and alternative methods of funding transportation; housing matters focused on Regional Housing Needs Assessment (RHNA) implementation; Vehicle Miles Traveled (VMT) policy changes, and alternative-fuel infrastructure progress from an energy-agnostic viewpoint. Overall, goals are to be equitable for both urban and rural benefit. CALCOG will continue to “tell regional stories so that lawmakers know what’s happening on the ground.” Also CALCOG has increased its staff and offers training for board members who serve on regional boards.

Director Haschak gave an example of a legal versus logistics situation: at a recent meeting of California State Association of Counties (CSAC), there was discussion with the Air Resources Board on electric vehicles and how to deal with snow, high elevations, and other conditions affecting battery performance and appropriate vehicle designs that are often not available.

#### **BACKGROUND:**

As the Regional Transportation Planning Agency, one of MCOG's regional responsibilities is the management of the Overall Work Program, a requirement of Caltrans, Office of Regional Planning. The OWP development process began in October with the planning project solicitation. In response to our annual call for transportation planning projects, two applications were received from local agencies for funding in MCOG's FY 2025/26 Overall Work Program (OWP).

TAC Members reviewed and discussed the applications at the TAC Meeting on January 15, 2025, proposing options for staff to begin moving forward in developing the draft document. After the Technical Advisory Committee has a chance to review and comment on the Draft FY 2025/26 Overall Work Program at the February Meeting, staff will present it to the MCOG Board for further review. The Draft OWP will include routine MCOG planning staff work elements, the two new local agency projects (listed below), a local match reserve for grant awards, as well as the Pavement Management Program Update.

The two new project applications for OWP funding in the Draft Overall Work Program include:

- *Co. DOT Combined Special Studies*
- *City of Fort Bragg – Stormwater Program Asset Management Plan*

The Draft OWP document is due to Caltrans by February 28<sup>th</sup> for review and comment. A requirement and minor formality of the submittal process for the RTPA is to obtain prior authorization from the Governing Board to authorize staff to release the draft for review and comment and allow circulation of the document to Caltrans. The MCOG Board will ultimately have an opportunity to review the draft in March and make any comments or recommendations, however, this allows staff the opportunity to submit the draft document on time to Caltrans, after allowing the TAC sufficient time to review and comment.

### **BACKGROUND:**

Purpose of this public hearing: The Transportation Development Act (TDA) requires that before any Local Transportation Funds are allocated for streets and roads purposes (unallocated revenues at fiscal year end), a process is conducted to identify any “unmet transit needs” that might be “reasonable to meet” for funding. This procedure has been followed annually by MCOG.

Since MCOG established a Local Transportation Fund (LTF) Reserve fund in 1999, excess funds have not been allocated at year end, but instead are carried forward to future budgets. However, there has been a general consensus of the MCOG Board, staff and stakeholders to continue identifying unmet transit needs annually. Past TDA performance audits have commended MCOG for conducting the formal process. It allows for public input that is useful in assessing which transit services should be provided. It provides a focus for the SSTAC’s annual workshop and satisfies the TDA requirement for a citizen participation process (Sec. 99238.5).

Testimony received for this hearing: The Social Services Transportation Advisory Council (SSTAC), a standing committee of MCOG, met for the annual Unmet Transit Needs workshop on January 8. The SSTAC recommended a list of six needs developed in the workshop; considered and endorsed seven needs from public input heard at MTA board meetings during the year; for a total of 13 needs, attached. Issues raised included mobility solutions for remote coastal areas, assisted services, non-emergency medical transportation, transit or expanded service for several communities, and a local and visitor serving route for economic development.

The SSTAC’s duties also include advising MCOG on any other transportation issues. This year, there were no further recommendations.

---

### **ACTION REQUIRED:**

The following process fulfills TDA requirements.

#### **Finding of Proper Notice:**

The Board makes the finding, by motion and vote, that a proper 30-day notice has been given. Notice of the public hearing was published by Ukiah Daily Journal (January 4, delivered also to Willits as The Willits News did not publish that Saturday), Fort Bragg Advocate-News (January 2), and Independent Coast Observer (January 3). The hearing was then rescheduled and continued from February 3 to February 10, so a second notice was or will be published in each of the newspapers on January 31 (Willits and ICO), February 1 (Ukiah), and February 6 (Fort Bragg). Only one notice of general circulation is required, which was more than met; proofs of publication available at this writing are attached. The notice has been posted on our web site and emailed to list subscribers. These actions more than meet the requirement.

#### **Public Hearing:**

The Chair opens the public hearing. Staff reports any written testimony received for the record, including findings of the SSTAC’s January 8, 2025 workshop. A list of identified needs is submitted, including unmet needs from public input received by Mendocino Transit Authority.

Public testimony is received. The hearing is closed.

**Board Action:**

The Board of Directors then determines whether any of the testimony received appears to be an “unmet transit need” according to the attached definitions adopted by MCOG, pending further analysis. The two main options for a motion are:

- 1) *"The testimony heard includes Unmet Transit Needs that appear to qualify under MCOG's adopted definitions, and those needs are directed to Mendocino Transit Authority for analysis and for further review and recommendations by the Transit Productivity Committee and Social Services Transportation Advisory Council."*
- 2) *"The testimony heard does not include any Unmet Transit Needs that appear to qualify under MCOG's adopted definitions, therefore there are no unmet transit needs found for fiscal year 2023/24, and the annual process is concluded."*

If the finding is “yes,” testimony does include unmet needs, the list of needs is directed to MTA to prepare an analysis that may include operational costs, ability to provide service, and prioritization of needs. Finally, the analysis would go to MCOG’s Transit Productivity Committee (TPC), in April or May 2025, for a recommendation to MCOG on which, if any, needs are “reasonable to meet” for inclusion in MTA’s 2025/26 Transit Claim, due to MCOG April 1, 2025. The analysis and recommendation also would be discussed by the SSTAC. In June, when MCOG allocates funds to the transit claim, a finding of “reasonableness” is made.

If none of the testimony qualifies as an “unmet transit need,” the Board makes a finding that “there are no unmet transit needs” and the annual process is ended. (Rarely, if ever, is this the case.)

---

**ALTERNATIVES:**

The Board may cancel or continue this noticed hearing. – *not recommended*

Also note TDA Sec. 99238.5(b): *“In addition to public hearings, the transportation planning agency shall consider other methods of obtaining public feedback on public transportation needs. Those methods may include, but are not limited to, teleconferencing, questionnaires, telecanvassing, and electronic mail.”* In this case we have used e-mail and MCOG’s website.

---

**RECOMMENDATION:**

Staff recommends that the Board:

- 1) Make a finding of proper notice and hear the staff report.
- 2) Hold the public hearing.
- 3) After hearing all testimony, make a finding that:

*"The testimony heard includes Unmet Transit Needs that appear to qualify under MCOG's adopted definitions, and those needs are directed to Mendocino Transit Authority for analysis and for further review and recommendations by the Transit Productivity Committee and Social Services Transportation Advisory Council."*

This hearing applies to transportation service needs for fiscal year July 1, 2025 through June 30, 2026. In addition to new public testimony, MCOG will hear needs reported to Mendocino Transit Authority during the past year, and findings of MCOG's Social Services Transportation Advisory Council. Issues may include but are not limited to: 1) transit services for the elderly, people with disabilities, and low-income or economically disadvantaged persons; 2) adequacy of both private and public transportation services, and 3) service improvements needed to meet expected travel demand.

### “Unmet Transit Needs” and “Reasonable to Meet” Process

#### Introduction

The stated intent of the Legislature in passing the Transportation Development Act (TDA) was to provide funding for transit, which would provide an essential public service through a balanced transportation system. The TDA administrative code specifically states, “it is the intent of the Legislature to improve existing public transportation services and encourage regional public transportation coordination.” The Public Utilities Code, in Article 2, Section 99220 provides even more succinctly: “to encourage people to use public transportation rather than private vehicles.”

Prior to using TDA funds for street and road improvements, Sections 99401.5 and 99401.6 of TDA require the Regional Transportation Planning Agency to hold a public hearing and make a determination that there are no unmet transit needs that can reasonably be met within the area of a county, city or eligible operator. As a result, the RTPA has the responsibility and authority to determine what constitutes unmet transit needs and whether or not such unmet transit needs can reasonably be met.

The Mendocino Council of Governments (MCOG), acting in its official capacity as the designated Regional Transportation Planning Agency for Mendocino County, accomplishes this in part through a public hearing process conducted by MCOG taking into account the recommendations of the Social Services Transportation Advisory Council and other various factors in the transportation planning process.

#### Definitions

The following definitions of “Unmet Transit Need” and “Reasonable to Meet” have been adopted by the Mendocino Council of Governments.

The unmet needs and reasonableness policies apply to new proposed services. Existing services will be evaluated through the existing performance standard policies established by MCOG, and reviewed by the Transit Productivity Committee.

1. Unmet Transit Need: Whenever a need to transport people is not being satisfied through existing public or private resources.
2. Reasonable to Meet: It is reasonable to meet a transit need if all of the following conditions prevail:

- a) Service will be capable of meeting the Transportation Development Act fare revenue/operating cost requirements and established MCOG criteria for new services
- b) Transit services designed or intended to address an unmet transit need shall not duplicate transit services currently provided either publicly or privately
- c) The claimant this is expected to provide the service shall review, evaluate and indicate that the service is operationally feasible, and vehicles shall be currently available in the market place
- d) Funds are available, or there is a reasonable expectation that funds will become available.

### BACKGROUND:

Following are the procedures for appointment of Board members to MCOG's standing committees. I have attached the appropriate sections of the bylaws for your reference. (Seats on the other standing committees are not filled by MCOG Board members.)

- The Council may appoint an Executive Committee, consisting of the Chair, the Vice Chair, and one other member reflecting a city-county balance.
- The Chair shall appoint two members to the Transit Productivity Committee. Note: to preserve MCOG's oversight role, staff advises that at least one should not also be serving as a board member of Mendocino Transit Authority.
- The Council shall appoint two members to CALCOG, including at least one Executive Committee member. One serves as the delegate and the other as the alternate.

The most recent appointments are:

- Executive Committee - Chair **Gjerde**, Vice Chair **Haschak**, and Director **Norvell**
- Transit Productivity Committee (TPC) – Directors **Gjerde** and **Carter**
- CALCOG – Director **Haschak** (Delegate) and Director **Norvell** (Alternate Delegate)

Additionally, there are two active Ad Hoc committees:

- Covelo SR 162 Corridor Multi-Purpose Trail Project – Directors Haschak and Carter
  - Regional Energy Network / Climate – Directors Gjerde, Haschak and Hansen
- 

### ACTION REQUIRED:

- a. Appointment of the Executive Committee. *Please note the annual meeting is to be scheduled for late February, preferably in the final week to allow for budget preparation and proper notice.*
  - b. Appointments to the Transit Productivity Committee. *One or two meetings are typically required in April and/or May to address transit performance and standards, MTA's annual funding claim, the unmet needs analysis, and any audit recommendations.*
  - c. Appointment of CALCOG Delegates. *Customarily CALCOG delegates meet annually at the Regional Leadership Forum and for quarterly business meetings. This year the Forum will be held in person March 5-7 in Sacramento. Other meetings may be offered in a hybrid format for remote attendees.*
  - d. Appointment to Ad Hoc committee. *Both of the ad hoc issues are still in progress. Appoint no more than three seats to each committee, i.e. less than a quorum.*
- 

### ALTERNATIVES:

- The Executive Committee is optional according to the bylaws, though serves an important role as the fiscal committee. The officers could meet with staff for annual business and as needed, ideally reflecting city-county balance.

- TPC membership is mandated by the bylaws, so there is no alternative without amendment.
- Annual CALCOG appointments are mandated also, so there is no alternative without amending the bylaws.
- Ad hoc committees may be dissolved when no longer needed or their purpose is completed.

---

**RECOMMENDATION:**

Appoint members to the standing committees described above, following MCOG's bylaws, and to the ad hoc committees. The Council may choose to approve a slate of appointments in one action.

## **Excerpts of MCOG Bylaws Amended June 6, 2022**

### **ARTICLE III - OFFICERS/STAFF/COMMITTEES**

#### Section 5. STANDING COMMITTEES

Section 5.2 Executive Committee: The Council may appoint an Executive Committee consisting of the Chair, the Vice Chair and one member from a city or the County. The Executive Committee may carry on the administrative and executive functions of the Council between regular meetings of the Council. The Executive Committee may also be used to oversee the personnel budget and policy issues and make recommendations to the full Council.

The Council shall attempt to appoint members to the Executive Committee that reflect a balance between City and County representation.

Section 5.4 Transit Productivity Committee (TPC): The TPC shall consist of five (5) voting members: two (2) members of the Council appointed by the Chair; two (2) members of the transit operator's Board of Directors; and one (1) senior centers representative to be selected by those senior centers under the Council's jurisdiction and then formally appointed by the Council. The TPC shall be staffed by the MCOG Executive Director or his/her authorized representative.

The purpose of the TPC will be to review and recommend on transit performance and productivity issues in accordance with approved standards adopted by the Council, including review of quarterly reports of the transit operator and to make recommendations to the Council for revisions to the standards. The TPC will review and make recommendations to the Council on the annual Transit Claim, and also provide input on the "unmet transit needs" process, including findings of the SSTAC. Meetings will be held at least once annually, or quarterly if warranted.

#### Section 6. ASSOCIATIONS

Section 6.1 California Association of Councils of Governments (CALCOG): The Council shall annually appoint two members of the Council, at least one of whom shall be an Executive Committee member, to the CALCOG organization for the purpose of voting on statewide issues. One member shall be the delegate, the other member, the alternate. The term of these appointments shall be for one year commencing on the first Monday in February when appointed and ending on the following first Monday in February or at the next year's committee appointments.

#### BACKGROUND:

The Transportation Development Act (TDA) mandates that Regional Transportation Planning Agencies maintain a Social Services Transportation Advisory Council (SSTAC). The council typically meets twice a year in fall/winter and late spring.

SSTAC appointments were last made at the August 12, 2024 MCOG Board meeting, as recommended at the SSTAC's May 30, 2024 meeting. Membership recruitment was discussed again at the SSTAC's January 8, 2025 meeting, when further nominations were made to reappoint members whose terms expire this April.

## **Social Services Transportation Advisory Council**

99238

Each transportation planning agency shall provide for the establishment of a social services transportation advisory council for each county, or counties operating under a joint powers agreement, which is not subject to the apportionment restriction established in Section 99232.

- (a) The social services transportation advisory council shall consist of the following members:
    - (1) One representative of potential transit users who is 60 years of age or older.
    - (2) One representative of potential transit users who is handicapped.
    - (3) Two representatives of the local social service providers for seniors, including one representative of a social service transportation provider, if one exists.
    - (4) Two representatives of local social service providers for the handicapped, including one representative of a social service transportation provider, if one exists.
    - (5) One representative of a local social service provider for persons of limited means.
    - (6) Two representatives from the local consolidated transportation service agency, designated pursuant to subdivision (a) of Section 15975 of the Government Code, if one exists, including one representative from an operator, if one exists.
    - (7) The transportation-planning agency may appoint additional members in accordance with the procedure prescribed in subdivision (b).
  - (b) Members of the social services transportation advisory council shall be appointed by the transportation planning agency which shall recruit candidates for appointment from a broad representation of social service and transit providers representing the elderly, the handicapped, and persons of limited means. In appointing council members, the transportation-planning agency shall strive to attain geographic and minority representation among council members. Of the initial appointments to the council, one-third of them shall be for a one-year term, one-third shall be for a two-year term, and one-third shall be for a three-year term. Subsequent to the initial appointment, the term of appointment shall be for three years, which may be renewed for an additional three-year term. The transportation-planning agency may, at its discretion, delegate its responsibilities for appointment pursuant to this subdivision to the board of supervisors.
-

- (c) The social services transportation advisory council shall have the following responsibilities:
- (1) Annually participate in the identification of transit needs in the jurisdiction, including unmet transit needs that may exist within the jurisdiction of the council and that may be reasonable to meet by establishing or contracting for new public transportation or specialized transportation services or by expanding existing services.
  - (2) Annually review and recommend action by the transportation-planning agency for the area within the jurisdiction of the council, which finds, by resolution, that (A) there are no unmet transit needs, (B) there are no unmet transit needs that are reasonable to meet, or (C) there are unmet transit needs, including needs that are reasonable to meet.
  - (3) Advise the transportation-planning agency on any other major transit issues, including the coordination and consolidation of specialized transportation services.
- (d) It is the intent of the Legislature that duplicative advisory councils shall not be established where transit advisory councils currently exist and that those existing advisory councils shall, instead, become part of the social services transportation advisory council and shall assume any new responsibilities pursuant to this section.
-

## **Citizen Participation Process**

99238.5

- (a) The transportation planning agency shall ensure the establishment and implementation of a citizen participation process appropriate for each county, or counties if operating under a joint powers agreement, utilizing the social services transportation advisory council as a mechanism to solicit the input of transit dependent and transit disadvantaged persons, including the elderly, handicapped, and persons of limited means. The process shall include provisions for at least one public hearing in the jurisdiction represented by the social services transportation advisory council. Hearings shall be scheduled to ensure broad community participation and, if possible, the location of the hearings shall be rotated among the various communities within the advisory council's jurisdiction. Notice of the hearing, including the date, place, and specific purpose of the hearing shall be given at least 30 days in advance through publication in a newspaper of general circulation. The transportation-planning agency shall also send written notification to those persons and organizations, which have indicated, through its citizen participation or any other source of information, an interest in the subject of the hearing.
  
  - (b) In addition to public hearings, the transportation-planning agency shall consider other methods of obtaining public feedback on public transportation needs. Those methods may include, but are not limited to, teleconferencing, questionnaires, telecanvassing, and electronic mail.

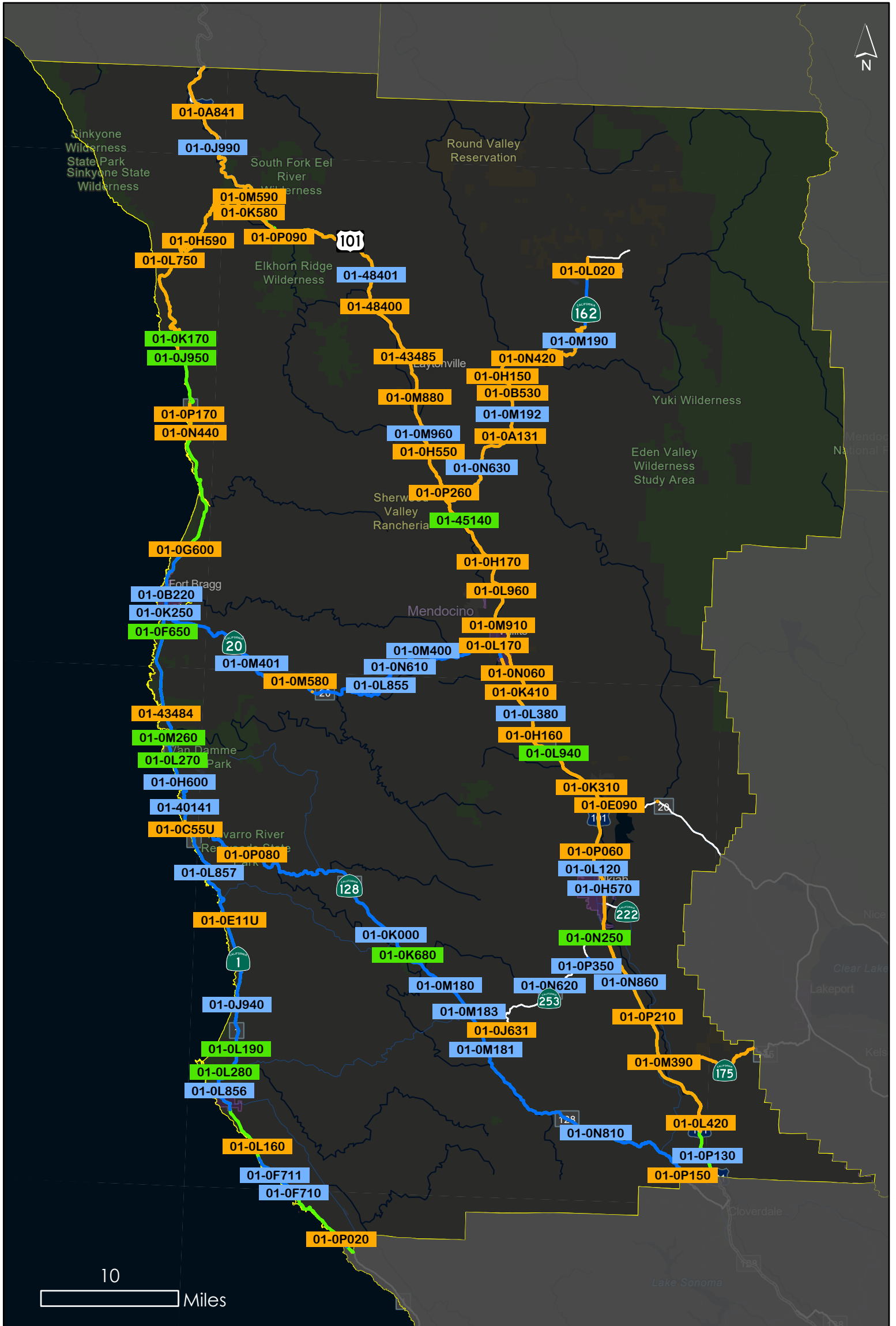
